A. TEAM Training Registration

B. NTGS Summit Recap

Last Friday 54 educators and district staff members representing 26 districts attended the non-tested grades and subjects summit to help increase familiarity with currently approved individual growth measures for teachers in non-tested areas. The gathering was focused on learning details about the existing models from current practitioners, as well as outlining the planning process for districts interested in implementing a portfolio model in the future. C. Achievement and Growth Measure Selections

Please review all achievement and grow th measure selections to make sure they are finalized in CODE prior to <u>Tuesday, April 15</u>. It is important that these decisions are made prior to testing. After April 15, you will not be able to make any changes to the achievement or grow th measure selections. On April 15, we will lock the 2013-14 Evaluation Data page in CODE from editing.

Please remember that to enter the grow th measure selections, you must scroll all the way over to the right-hand part of the screen to find the 'Grow th Measure' column with the drop-down options. For more information on the options for achievement and grow th, please see the Achievement Measures Worksheet. You are not required to enter the achievement measure scales into CODE, but we recommend doing so to ensure that you know how to calculate the scale scores when the data is returned or in the event of a grievance.

D. 2014 First to the Top Educator Survey

This April, Tennessee teachers and school administrators will have the opportunity to share their feedback on major education initiatives in the state. The survey requests teacher input on evaluation, the Common Core State Standards, and other issues. Survey responses are provided directly to the Tennessee Consortium on Research, Evaluation, and Development (TNCRED), an independent research organization at Vanderbilt University. Teachers'

confidentiality is fully protected as no individual responses will be shared. Survey findings will be reported in the aggregate-absolutely no participants will be identified in study reports.

Last year, almost 25,000 teachers responded to the survey, representing 40 percent of all teachers across Tennessee. Based on this feedback, we adjusted our teacher evaluation system in several ways. Please read an overview of last year's survey results for more information. Teacher feedback this year will inform our focus in professional development, the types of resources we provide, and our implementation of the Response to Instruction and Intervention framew ork. Districts with at least 30 respondents and a participation rate of 50 percent or higher will receive a district-level report of survey findings.

A survey invitation will be sent to teachers and administrators in your district between April 2 and April 8 in an email from tnconsortium@vanderbilt.org.
