Governor Haslam Outlines Initiatives to Support Teachers

At last week's Learning Forward conference, Gov. Bill Haslam announced several key initiatives to support Tennessee teachers in response to direct feedback from educators across the state. The proposals reflect input that the governor received during statewide meetings with more than 150 educators and the education summit he co-hosted in September. 2013-14 Evaluation Data Close-Out

Last week, we sent completion reports for the 2013-14 school year to directors of schools. As a reminder, we will close off the ability to make changes to 2013-14 evaluation data on Monday, Jan. 5. At that point, we will be unable to make corrections related to outstanding grievances, data entry errors, or incomplete achievement scores. Educators without complete data will receive partial year exemptions. If you have any questions about this process, please reach out to TEAM.Questions@tn.gov as soon as possible.

Observation Entry Deadline Reminder

As we approach the holiday season, please remember that the observation entry deadline for fall observations is **Monday**, **Jan**. **5** for teacher observations and **Thursday**, **Jan. 15** for administrator observations. It is especially important to meet the entry deadline for administrator observations, as first semester observations are weighted onethird and second semester observations are weighted two-thirds. In order to avoid a burdensome amount of data entry during the holidays and provide more transparency for those being observed, it is important to enter and submit observations into CODE as you go.
