Knowledge of Students

The key to this indicator is the educator's ability to know the needs of the students they serve to effectively provide appropriate services.

Evaluator Expectations

During the conference, possible evaluator questions could be:

- "What practices do you have in place to ensure you know the needs of the students in the building?"
- "How do you use the data to develop an individualized scope of work?"

Possible sources of evidence could be:

- student and teacher surveys,
- progress monitoring data, and/or
- activities chosen to differentiate the approach to student needs.

This indicator aligns strongly with *Activities and Materials, Motivating Students, and Delivery of Services.*

Indicator Descriptors

- Educator practices display an understanding of each student's individual needs.
- Educator practices incorporate student interests and cultural heritage.



Evidence Capture Example

As you watch this video, note how the interventionist discusses with the principal her plans for the students in her small group. Decisions are based on conversations with teachers as well as assessments identifying the students' specific skill deficits. This is evidence of descriptor one.



Evidence Capture Example

As you watch this video, note how the school counselor collects background knowledge of the students' interests and leverages their interactions with each other. She uses this information to create activities for her small group lessons. This is evidence of indicator two.

Note how the principal can collect evidence through classroom observation and/or during a conference with the educator.





Descriptor 1: The interventionist discussed how she differentiates the lessons and activities based on the students' needs.




