# **Organization of Services**

The key to this indicator is the educator's ability to use school/student data to plan a scope of work based on reflection, feedback, and stakeholder needs.



# **Evaluator Expectations**

During the conference possible evaluator questions could be:

- "How do you capture data to determine your stakeholders' needs?"
- "How do you use the data to develop your scope of work?"
- "How have you refined your service based on stakeholder feedback?"


#### Possible Sources of Evidence could be:

- examples of data collected and analyzed,
- changes in programs based on data analysis,
- a yearly plan aligned to the school plan, and/or
- samples of student, peer, or parent feedback.

This indicator aligns strongly with Service Structure and Pacing, Knowledge of Students, and Delivery of Services.

## **Indicator Descriptors**

- The educator provides a thoroughly developed, defined, and comprehensive scope of services.
- Educator utilizes school and/or student data to inform the organization of services.
- Educator uses self-reflection and evaluation to refine organization or services.



# **Evidence Capture Example**

As you watch this video, note how the instructional coach describes her method of leading teachers in PLC meetings to develop assessments based on TCAP data and the students' struggles with specific standards. This is evidence of descriptor two.

Also note how the coach discusses organization of services by using both student data trends and observation data from classrooms. This is evidence of descriptor one.



**Descriptor 2:** The instructional coach used student data to determine the needs he addressed with teachers during PLC meetings. He consistently used data to organize his services.







#### **Possible Evidence**

**Descriptor 1:** The school counselor consistently provided a comprehensive scope of services to meet the needs of students she serves. She used data and feedback to deliver support that was thoroughly developed to meet the needs of students.

**Descriptor 2:** The school counselor used school data such as transcripts, college application deadlines, and course enrollment to organize her service.

**Descriptor 3:** She reflected on feedback from administration and teachers to develop and refine her scope of services for the year.



**Descriptor 2:** The instructional coach informed organization of services based on trends in student data and teacher observations. She utilized student assessment data to develop PLC meetings with teachers. She also planned PLC meetings based on teacher data collected during walk-through observations.
