
TEAM Evaluator Certification Feedback Survey Results

The department solicited and received valuable feedback from certified evaluators regarding improvements to the TEAM Evaluator Certification Training. Evaluator Suggestions		Department Action
Some trainees are better visual learners than auditory learners	>>>	A trainee now can choose to read the transcripts and/or listen to the voice recording for each slide in the module presentations, with the exception of video slides.
Embed links to documents and resources for training	>>>	The training now has links throughout the module presentations to access guidance documents, rubrics, scripting templates, and various other resources from the department on the <u>TEAM website</u> .
Reconsider how often evaluators have to recertify	>>>	The yearly certification of evaluators is required by the State Board Evaluation Rule <u>0520-02-01</u> (page 7). Visit the <u>Tn.gov website</u> for board meetings and policies under review.
Reword questions to add clarity	>>>	Each year, missed questions are reviewed, and feedback from evaluators is considered when preparing questions for the next year's evaluation.
Communicate updates to guidance documents	>>>	Updates and newly released documents are announced in the weekly CUFD email, the monthly evaluation configurator email, and can be found under the Recently Released section on the home page of the TEAM-tn.org website. View and sign up for our monthly Evaluation Configurator email here .
Provide training on other models such as TIGER	>>>	While the department has approved the use of alternate observation models such as TIGER, the department only provides direct support for the state evaluation model, TEAM. For more information on training for models other than TEAM, please contact your district Evaluation Configurators.
