




# AGM-URS Description Alternative Growth Measure | TEAM-TN





## **Alternative Growth Measure-URS Description**

#### T.C.A. § 49-1-302

Each **district and charter** school must utilize at least an approved individual growth measure (student growth portfolio or universal reading screener) for at least one **non-tested teacher group.** 

<u>T.C.A. § 49-6-105</u>, state board policy <u>5.201</u>, and state board rule <u>0520-02-01</u>
Districts and charters that receive pre-kindergarten program approval under <u>T.C.A. §§ 49-6-103 – 49-6-110</u> (**VPK funding**) **must** utilize the student growth portfolio model or the alternative growth measure (AGM), state-board approved universal reading screener.

#### Tennessee Literacy Success Act

Allows for districts and charters to use their **Universal Reading Screener (URS)** as an approved alternative growth measure (AGM) for **PreK-2** teachers.

State board policy <u>5.201</u>

The alternative growth measure (AGM) growth score comprises **35%** of the teacher's Level of Overall Effectiveness (LOE) score.

## **Alternative Growth Measure-URS Description**

 Measures approved as universal reading screeners by the state board in policy <u>3.302</u> as required by the Tennessee Literacy Success Act include the following:


 All measures may be used as an alternative growth measure (AGM) for all students in grades K-2. Starred measures may be used as an alternative growth measure (AGM) in Pre-K.

# **Teacher Rostering Guidance** AGM Teacher Rostering Guidance



- The <u>AGM-URS Teacher Roster Guidance Document</u> outlines the instructions for AGM leads to access their AGM teacher rosters in TNShare.
- A pre-populated roster generated from the department's Education Information System (EIS) contains the English Language Arts (ELA) teachers listed in the district/charter's selected implementing grade(s).
- Any additions to the roster must be updated in EIS prior to final roster submission. To update EIS, contact the district EIS Coordinator.



- AGM leads access the teacher file in TNShare using their Single Sign On (SSO) account.
- Download the roster file.



- Confirm teachers listed should be receive an AGM-URS growth score.
- Remove teachers listed that do not receive an AGM-URS growth score due to subject taught, grade taught, or PYE status. Select the reason for removal.
- Add teachers only if corrections have been made in EIS. The teacher will not receive an AGM-URS score regardless of the information on the roster if the EIS coordinator has not corrected the teacher in EIS. Select the reason for add.





## **Receiving Growth Scores**

- Teachers submitted on the AGM-URS teacher rosters will receive individual growth scores based on data from the selected Alternative Growth Measure-Universal Reading Screener (AGM-URS).
- In the absence of this data, no growth score can be calculated, and the educator may receive an incomplete. With an incomplete growth score, an LOE score cannot be generated.
- Rostered teachers not meeting n-count (at least 6 students) will have LOEs generated as non-tested teachers using a school composite TVAAS score.




